## BOARD MINUTES BEMENT COMMUNITY UNIT SCHOOL DISTRICT 5 REGULAR MEETING OF THE BOARD OF EDUCATION FEBRUARY 10, 2021

The regular meeting of the Bement Community Unit School District 5 Board of Education was held Wednesday, February 10, 2021 in the small gym. The meeting was called to order by board president Todd Scott at 7:00 p.m.

High school scholastic bowl members spoke to the board about their experience participating in extra-curriculars in a "remote-world".

Mr. Kepley gave his middle school/high school principal's report on the Spelling Bee, the Students to Europe trip, homecoming activities, and the Middle School Students of the Quarter.

Mr. Cline updated the board on the ever-changing IESA/IHSA guidelines and updated them on schedules and post-season play. Mr. Cline presented the proposed CGB co-op proposals to the board. He told the board that the Cerro Gordo administrators will be presenting the same proposal to their board at their next board meeting. If the proposal is accepted by both boards, the administrators from both schools will begin work on the language. A motion was made by Strack and seconded by Rogers that the board accept the resignation of Jeremy Moore as assistant high school baseball coach effective immediately. Motion carried by a unanimous roll call vote.

A motion was made by Stoerger-Flavin and seconded by Strack that the board accept the resignation of Stephanie Eccles as assistant high school volleyball coach effective immediately. Motion carried by a unanimous roll call vote.

A motion was made by Scott and seconded by Rogers that the board employ Victoria Herrmann as assistant high school volleyball coach. Motion carried by a unanimous roll call vote.

A motion was made by Rogers and seconded by Somers that the board employ John Strack as middle school girls track coach. Motion carried by a unanimous roll call vote.

A motion was made by Scott and seconded by Stoerger-Flavin that the board employ Christina Sweet as the PreK-5 Principal/Athletic Director for the 2021-2022 and 2022-2023 school years. Motion carried by a unanimous roll call vote.
